<b>Required Specimen Type</b>	<ul style="list-style-type: none"> <li>Hydrogen and methane respiratory samples</li> </ul>
<b>Medical Supplies</b>	<ul style="list-style-type: none"> <li>Hydrogen and methane breath kit</li> <li>Consent form (RR-05-FM-011)</li> </ul>
<b>General Guidelines</b>	<ol style="list-style-type: none"> <li>All specimens must include a double identification (first and last name of the patient and date of birth or medicare number).</li> <li>The use of gloves is required when handling all biological specimens.</li> <li>A valid requisition must include the following information :           <ul style="list-style-type: none"> <li>First and last name of the patient, date of birth or medicare number and gender.</li> <li>Date and time of specimen collection and signature of collector.</li> <li>Physician's full name, signature and license number (or other qualified prescriber).</li> <li>Any relevant clinical information.</li> <li>Requested tests.</li> </ul> </li> </ol>
<b>Patient Preparation</b>	<ol style="list-style-type: none"> <li>The following instructions are intended to guide you through the preparation process for your Hydrogen Breath tests. Please read the instructions carefully and follow them correctly.</li> <li>There will be a minimum interval of 3 days between breath tests if done at the main laboratory or 5 days if done at any of the acquisition centers.</li> <li><b>14 days prior</b> to the first test:           <ol style="list-style-type: none"> <li>No antibiotics, probiotics, no bowel cleansing as for colonoscopy, barium enema or virtual colonoscopy.</li> <li>Diarrhea may affect the test result.</li> </ol> </li> <li><b>48 hours</b> before the test, you should avoid alcohol.</li> <li><b>The day before</b> you start the breath test, a 24 hour preparation is required consisting of a 12 hour restricted diet and a 12 hour fasting period. Each visit will take 3 to 4 hours.           <ol style="list-style-type: none"> <li><b>The first 12 hours prior the test</b>, you can drink water, coffee or tea (no sugar / artificial sweetener or added cream). You must follow the diet bellow :               <ul style="list-style-type: none"> <li>Chicken, fish or turkey baked or boiled (salt and pepper only);</li> <li>White rice steamed;</li> <li>Eggs;</li> <li>Chicken or beef broth;</li> <li>White bread.</li> </ul> </li> <li><b>The second 12 hours prior</b> to the test:               <ul style="list-style-type: none"> <li>No food, no drinks (except small amount of water up to 1 hour before)</li> </ul> </li> </ol> </li> <li><b>The day of the test:</b> <ol style="list-style-type: none"> <li>If possible and with permission from the prescribing physician for safety reasons, <b>delay your morning oral medication until after completion of the test.</b></li> <li>1 hour before the exam: <b>no sleeping, no vigorous exercise, no smoking including second hand smoke</b> until the end of the exam.</li> <li>Upon your arrival at CDL Laboratories,               <ol style="list-style-type: none"> <li>You will be required to drink a special solution according to the test prescribed;</li> <li>You will be required to blow into a collection bag every 15 to 20 minutes for 3 hours-4 hours.</li> </ol> </li> </ol> <p><b><u>Consult your health care professional if you have any questions regarding medications that might influence this test or for further information, CDL laboratories are not able to answer these questions.</u></b></p> </li></ol>

<b>Additional Information</b>	<p>Hydrogen Methane Breath tests requires the use of a specific instrument only available at our head office. However the sample collection may be performed at any CDL site listed below.
